Some of the barriers that hindered parent participation during the previous school year were work hours of family member/guardians, language barriers with our ELL families, and transportation issues. Although we cannot help to overcome transportation issues, we can assist with adjusting hours and offering assistance with our ELL families. Our events throughout the years will have different timeframes to help meet the needs of families that may work later. We will also work on translating materials that are shared to families to ensure that they are receiving information about parent involvement and activities.

We will also organize regular events, such as School Advisory Council meetings, family engagement activities, and family fun or STEM nights to foster a sense of community and collaboration. We have established a dedicated space within the school as a Parent Resource Center, equipped with books, brochures, and online

resources on various educational topics, games and books to encourage family engagement, college applications, financial aid, and more.

Regular parent-teacher meetings will be organized to discuss the progress of students. This will help parents understand their child's academic strengths and areas for improvement, and how they can support their child's learning at home. Parents will be encouraged to volunteer in school activities, such as reading to students, assisting with classroom activities, or helping to organize school events. Books and board games are purchased to pass out to families to encourage family involvement. This will help parents become more involved in the school community and gain a better understanding of the school's educational practices. Over the summer, several teachers attended AVID Summer Institute to help parents and students set clear academic and social goals. During teacher pre-planning week, professional development was provided for helping teachers make parent contact, utilize programs and resources for highly rigorous instruction, and utilizing the new ParentSquare communication app. Additional training was provided to our clerical staff regarding advanced customer service and our paraprofessionals receive ongoing instruction on student and parent communication techniques.



Some concerns still arise of communication from teachers to parents in a timely manner, in regards to grades and behavior. Parents have shared that information being shared out has improved and helped to ensure they were better informed.
