NOW, THEREFORE, BE IT RESOLVED BY THE SUMTER COUNTY SCHOOL BOARD, IN OPEN MEETING THIS 7th DAY OF DECEMBER, 2021, IN THE CITY OF BUSHNELL, SUMTER COUNTY, FLORIDA, THAT:

#### **DISTRICT I**

The boundaries of Sumter County School Board Member Residence Area District I shall be as shown, depicted, and described in Exhibit A attached to this Resolution and incorporated herein by reference.

### **DISTRICT II**

The boundaries of Sumter County School Board Member Residence Area District II shall be as shown, depicted, and described in Exhibit A attached to this Resolution and incorporated herein by reference.

# **DISTRICT III**

The boundaries of Sumter County School Board Member Residence Area District III shall be as shown, depicted, and described in Exhibit A attached to this Resolution and incorporated herein by reference.

#### DISTRICT IV

The boundaries of Sumter County School Board Member Residence Area District IV shall be as shown, depicted, and described in Exhibit A attached to this Resolution and incorporated herein by reference.

#### DISTRICT V

The boundaries of Sumter County School Board Member Residence Area District V shall be as shown, depicted, and described in Exhibit A attached to this Resolution and incorporated herein by reference.
