

NOTICE OF TAX FOR SCHOOL CAPITAL OUTLAY

The District School Board of Sumter County will soon consider a measure to impose a 1.459 mill property tax for the capital outlay projects listed herein.

This tax is in addition to the school board's proposed tax of 4.233 mills for operating expenses and is proposed solely at the discretion of the school board.

The capital outlay tax will generate approximately \$16,655,031 to be used for the following projects:
