3. Barriers: Describe the barriers that hindered participation by parents during the previous school year in parental involvement activities. ### The Sumter PREP Academy's main barriers are the following:

- a) Only one alternative education school for the entire county including South and North End. The parents in the North End have about 30 to 45 minutes drive to our school in comparison to the South End. Parents residing in the North End state that their main reason for not attending is lack of transportation or funds to pay for gasoline.
- b) Our school parent's population is economically disadvantaged including Exceptional Student Education (ESE).
- c) English Language Learners (ELL) have limitations in literacy in terms of reading comprehension and cultural insensitivity. Parents of ELL students often speak only Spanish.
- d) Parent obligations with other younger siblings.
- e) Our students are being raised by grandparents who are not versed in technology.
- f) Limited Wi-Fi Signal.
- g) Lack of nutrition and personal hygiene.

# To overcome these barriers the following measures will be instated:

- a) For parents who are unable to attend, the resources will be sent electronically via the Parent Square app. Also, whenever possible parents will have the option to join sessions via TEAMS, or by phone call.
- b) Having in mind our parents and guardians, our communications will be written in plain, simple English, for Spanish Speakers and Readers home communications will be sent in Spanish, and a translator will be on site. In addition, Parent Square automatically translate to their preferred language. Thus, parents/guardians are able to receive our communications in their home language.
- c) We will consider other school's and community calendars when we schedule parent's activities.

- d) The activities below will be planned to address constantly the new barriers and to discuss specific strategies.
- e) Send paper copy versions of the electronic materials home.
- f) We provide students Wi-Fi with a portable My-Fi device.
- g) We provide hygiene bags for parents, students, and siblings to remove that barrier. Our PBIS Breakfast is not catered and is instead home-cooked.

The Orientation Day for 6th to 12th grade and the Title 1 Annual Parent meeting is hosted to introduce parents to our school expectations, transitioning goals, scholar handbook, Title 1 essential information, and volunteering opportunities, and opportunities to join the School Advisory Committee and to allow parents to meet our faculty.
