Flexible Parent Meetings

Immediately following the first quarter, evening parent conferences will be scheduled to discuss student progress. Teachers reserve two evenings from 3:15-7:00 for conferences. All parents are encouraged to participate. To provide flexibility and ensure all parents are accommodated, conferences may also be scheduled before or after school or during teacher planning time as needed throughout the year. Telephone conferences and email also provide flexible options. If needed, there is a District translator that is available to provide translations for Spanish speaking parents. Several Title I Parent Involvement Meetings will occur throughout the school year in conjunction with the School Advisory Council meetings or separately to discuss and plan parent involvement activities as related to school events. Meetings will be planned for after school and before evening parent involvement events to allow more parents to attend. At times, information may be sent for review and suggestions via email to interested parents and community members. In addition, parents will be invited to attend the District PAC meetings, held twice a year- Fall and Spring.
