IMPORTANT INFORMATION

Home education is a non-public school enrollment in lieu of attending a public, charter or private school. The parent/guardian assumes all educational responsibilities. **Sumter County does not provide books, computers, curriculum or materials.**

- If you are considering virtual school as your Home Education curriculum, **it is your responsibility to enroll your child/children in the virtual program of your choice.** There are free district and state virtual instruction programs available to Florida residents with an established Home Education Program.

District – Sumter Virtual – teachers hired by the School District

State – Florida Virtual School – statewide teachers

- For either option above, you will enroll at: [FLVS.net](https://www.flvs.net). You will select “Home Education Program” as your physical school in your FLVS account. You will create your parent/guardian account and your student's account through FLVS.net. The parent **must** approve all courses through a parent/guardian account.
- Virtual school is only one option. Parents/guardians have the freedom to research and select any curriculum for their home education program.
